Know all men by these Presents;

. That we, the undersigned, a majority of whom are citizens and residents of the State of California, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of California, AND WE HEREBY CERTIFY,

FIRST, That the name of said Corporation shall the SCAVENCERS PROTECTIVE UNION OF OAKLAND CAL.

SECOND, That the purposes for which it is formed are social and not directly for profit and are (1) to form a more perfect union among the members of the trade in the business of cleaning the Cities and Towns of the County of Alameda, or any of them, of their refuse. (2) To better the so sial and individual condition of its members through union and mutual protection and to assist them when sick. (3) The creation of a fund for the benefit of members of this associstion and to defray such expenses as may be necessarily incurred in carrying out the objects of this association and to that end to invest and re-invest such fund or funds in income producing investments.

THIRD, That the place where the principal business of said corporation is to be transacted is the City of Dakland, County of Alameda, State of California.

FOURTH, That the term for which said Corporation is to exist is fifty years from and after the date of its incorporation.

That the number of Directors or Trus-FIFTH, tees of said Corporation shall be eleven and that the names and residences of Directors or Trustees, who have been appointed for the first year and to serve until the election and qualification of such officers, are as follows, to wit;
